

On the afternoon of Wednesday 7 October, delegates will be able to do business in The Travel Showcase at the CCIB.

Each ABTA Tour Operator and Travel Industry Partner Company attending the Convention will be allocated a complimentary table* within the Travel Showcase but additional fees apply for the Cruise Forum Showcase** and Luxury Travel Forum Showcase.

Non Members may purchase a table in the Showcase at this year's reduced rate of £295 per table.

ABTA Tour Operators and Travel Industry Partners may opt to join the pre-event appointment booking system for a fee of £295 per table.

As well as the networking tables, there is also the opportunity for you to purchase raw space to provide something fun and interactive in the Showcase area. This will of course be subject to ABTA's approval. Minimum raw space available is 3x2m and the rate is £250 per square metre.

All delegates taking part in the Showcase must be registered for The Travel Convention or the relevant satellite event.

* ABTA Member and Travel Industry Partner Companies will automatically be allocated a table upon registration and are not required to complete a booking form unless they wish to upgrade their table.

** The Cruise Forum Showcase is open to Cruise Lines and a limited number of sponsoring companies. Only Cruise Lines with a presence in the Cruise Forum Showcase will be able to attend the Cruise Forum Seminar.
